Terms and conditions

Welcome to Lawrence county Indiana's first and only cage free daycare and boarding facility! Thank you for trusting us to care for your beloved furkid; it is an honor and privilege. Please feel free to reach out to us via text, call or our Facebook page, Hoosier Doggie Daycare & Boarding, at any time. Your dog's first visit to Hoosier Doggie is an evaluation, we have the right to refuse service based on any aggressive or disturbing behaviors.

We strive to provide the best care for your furkid while allowing free play during any daycare, boarding or bathing visit. We do our very best to ensure that all guests have a safe and secure visit. However, please understand that due to our cage free nature, there are inherent risks of injury or illness. Dogs commingle in packs throughout the day and night. We separate dogs into packs based on not only size, but energy level and temperament as well. Minor injuries from free play in a pack may incur such as scratches, abrasions or sprains. We do our very best to prevent and stay on top of any play that may lead to aggression. Dogs are watched and listened to closely but there is always a risk as dogs are unpredictable. If at any time a dog becomes aggressive toward another dog or human, said dog will be separated from the pack and no longer be able to return.

Hoosier Doggie will not be held responsible for any cost incurred due to injury or illness sustained during a stay in our facility. If your pet is the cause for illness or injury to another dog or human during its stay, you shall be liable for any costs associated. Canine illness is very common. Dogs are required to be vaccinated; However, germs are virtually everywhere. We strive to keep our facility clean and sanitized but there is always a risk of bacterial, viral or parasite infection, especially considering our cagefree nature. Hoosier Doggie shall not be responsible for any illness or vet bills resulting from such an illness. Please be courteous and keep your dog home when he or she is showing signs of illness.

Hoosier Doggie Daycare & Boarding Rules & Regulations

1. As mandated by insurance, no one is allowed access to any play areas besides staff. This is for your own safety as many dogs do not trust strangers. We have an open-concept facility viewable from the lobby.
2. All dogs must remain on a leash until in the control of our staff. No retractable leashes.
3. All dogs must be on a flea and tick program. A \$50 removal fee will incur for any fleas found on your dog.
4. A \$10.00 holiday fee per dog (1 fee per visit) will be added over New Years, spring break, Easter, Memorial Day, July 4th, Labor Day, Thanksgiving and Christmas as well as the coinciding weekends. Holiday hours are 12-4pm. Our lobby is closed on Christmas Eve, Christmas Day and New Years Day and The Dog man's Birthday.
5. We are very flexible with scheduling. However, a \$20.00 out-of-hours fee will be added for any check ins or check outs outside of business hours.
6. We do not charge for cancellations but appreciate a 24-hour notice so the spot may be given to others.
7. Daycare is included in the cost of boarding until 4pm on the scheduled day of check out. A \$15.00 daycare fee will be added after 4pm on the day of check out.
8. Pet owners must supply food. House food can be provided for \$5.00 per day with no limit based on size nor schedule.
9. Medications are administered free of charge; please complete a new medication form for each new visit.
10. We provide toys, bedding, food and water bowls for our guests. Hoosier Doggie will not be responsible for lost or damaged items. Todd is an honest and fair business man. Please be upfront and honest regarding your concerns and your dog's personality and habits. Hoosier Doggie has the right to deny services at any time for aggression toward humans, other dogs or is hard-to-handle based on Todd's discretion.
11. Shot records (Hard Copy) must be provided from a vet and kept current.
12. Permission shall be granted for Hoosier Doggie staff to have access to dogs' shot records.
13. Permission shall be granted for Hoosier Doggie staff to acquire any needed medical treatment during any stay. Pet owner will be responsible for vet costs
14. Hours and rates are subject to change without notice. .
